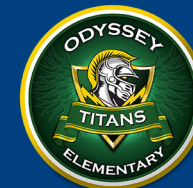

# TITLE 1 OVERVIEW

## What is Title I?

Title I, Part A of the Every Student Succeeds Act (ESSA) is a federal grant that provides supplemental funds to schools with high percentages of children from low-income families to help ensure that all children meet the state academic standards. At Odyssey Charter Schools, Title I is a school-wide program model so every student in the school benefits from Title I funding, regardless of family income.

## How do schools qualify for Title I funds?

Schools qualify based on demonstrating that their student population has a sufficiently high percentage of economically disadvantaged students. In accordance with federal law, funds are allocated to schools to support the purpose of Title I and the goals of the Schoolwide Improvement Plan.



## Purpose of Title I

The purpose of Title I is to ensure that all students have a fair, equal, and significant opportunity to obtain a high-quality education, and reach at a minimum, proficiency on challenging state academic achievement standards and state academic assessments.

Title I funds assist schools in improving student achievement and are used to enhance the regular district instructional program.

## Family Engagement

The plan, developed jointly with parents, describes how the school will carry out the parental engagement requirements. The PFEP is located on the school's website.

Each Title I school must have a School-Parent Compact that is written jointly with parents. The compact outlines how parents, the school, and students will share the responsibility for improved student academic achievement. The School-Parent Compact is discussed during parent/teacher conference.
